What is this type of insurance?

This cover can help with the cost of repair if you should you accidentally damage the alloy wheels on your vehicle.



What is insured?

- We will pay for the cost of repair resulting from accidental damage to the alloy wheels which has occurred within the geographical limits of the policy.
- ✓ Our liability per claim shall not exceed £100.
- √ The maximum number of Claim(s) during the Period of Insurance shall not exceed:
 - Three (3) Claim(s) under a twelve (12) month policy.
 - Six (6) Claim(s) under a Twenty-four (24) month policy.
 - Nine (9) Claim(s) under a Thirty-six (36) month policy.



What is not insured?

- Any damage occurring or any claim made within the claims waiting period.
- X Theft of your alloy wheels.
- Corrosion, pitting, discolouration, tar staining, neglect or a defect which the approved repairer states is not the result of accidental damage.
- X Alloy Wheel(s) with diamond (laser) cut rims, split rim construction or with polished or chrome effect finishes.
- Damage caused by fitting or changing the tyre or wheel.
- Any repair required as a result of a cracked or buckled alloy wheel.



Are there any restrictions on cover?

- There is a claims waiting period. This is a 14-day period from the start date of the policy where any claims will be excluded.
- You must be a GB resident.
- You must be the registered owner and keeper of the vehicle or the person financing it on behalf of the owner or registered keeper.
- The vehicle must be under 7 years old from the date of manufacture, with mileage under 70,000 at the start of the policy period of cover.
- Your vehicle must be in a good state of repair and not have any pre-existing damage to the alloy wheels.
- The vehicle must not be included in the "Excluded Cars" list shown in the policy wording.



Where am I covered?

√ Your policy will cover you in England, Scotland, and Wales and a maximum of 30 days in the European Union during any twelve-month period.



What are my obligations?

You must provide full and accurate information to all questions asked. Your answers must be true to the best of your knowledge and belief. Your answers will form part of the statement of facts on which your policy will be based. If you become aware that information you have given us is inaccurate or has changed, you must inform us as soon as possible. Failure to do this may invalidate your policy and claims may not be paid.



When and how do I pay?

You can pay your premium as a one-off payment by debit card, credit card, PayPal or Apple Pay. Alternatively, you can pay by direct debit over 10 months.



When does the cover start and end?

Your cover will start and end on the dates stated in your policy documents.



How do I cancel the contract?

If you decide that for any reason, this policy does not meet your insurance needs then please return it within 30 days from the date of purchase or the day on which you receive your policy documentation, whichever is the later. On the condition that no claims have been made or are pending, the premium will be refunded in full. If you wish to cancel after the 30-day cooling off period, please contact the Administrator.
